TFP course objectives — to teach

- the concept of psychological structure and its relation to the specific symptoms of borderline personality
- the range of borderline pathology and its different presentations
- the centrality of identity diffusion in borderline personality disorder and the role of identity integration in resolution of BPD
- the strategies, tactics and techniques of effective psychodynamic psychotherapy for borderline personality;
- how to perceive and identify object relations dyads (pairings of representations of self and other) as they are enacted in the therapy.
- the therapist to be aware of and use countertransference
- the concept of reflective functioning and its role in psychological well-being.
